#### What is the purpose of this update?

## Description of this fund

The Forsyth Barr New Zealand Equities Fund invests in New Zealand shares. We aim for positive long-term returns. These kinds of investments will typically have moderate to high levels of movement up and down in value.

#### What are the risks of investing?

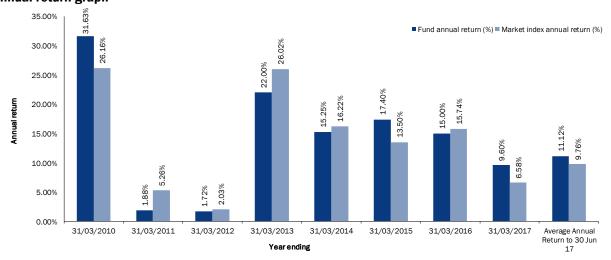

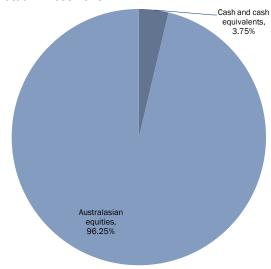
#### **Example of how this applies to an investor**

Jane had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jane received a return after fund charges were deducted but before tax of \$1,459 (that is 14.59% of her initial \$10,000). This gives Jane a total return after tax of \$1,319 for the year.
