What is the purpose of this statement?

The fund aims to provide a competitive at-call return by investing in at-call unsecured debt securities with Westpac via Forsyth Barr Cash Management Nominees Limited.



How has the fund performed in the past?

Members were also charged membership fees of \$36 over the year.



Example of how this applies to a member

Jane had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jane received a return after func fees and tax were deducted of \$172 (that's 1.72% of her initial \$10,000). Jane also paid \$36 in membership fees. This gives Jane a total return of \$136 for the year
