## What is the purpose of this statement?

This statement provides key information about the Forsyth Barr KiwiSaver Scheme Personal Choice – Global Equities Sector. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

## Description of the fund

The general objective fund is to achieve positive long-term returns by investing in international equities, subject to the higher risks associated with investments in international equity markets. The fund is actively managed.



#### What fees were members charged?

Members were also charged membership fees<sup>4</sup> of \$36 over the year.



### Example of how this applies to a member

Jane had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jane received a return after fund fees and tax were deducted of \$1,821 (that's 18.21% of her initial \$10,000). Jane also paid \$36 in membership fees. This gives Jane a total return of \$1,785 for the year.

#### **Notes**

- <sup>1</sup> Returns in this statement are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax rate may be lower.
- <sup>2</sup> Fund fees are fees charged as a percentage of a member's interest in the fund (i.e. as a percentage of their KiwiSaver account balance).
- <sup>3</sup> Fees arising from investments in funds managed by managers other than associated entities of Forsyth Barr Investment Management Limited are not readily available given that publicly available unit prices are already net of fees. These fees have therefore been estimated by applying the fee percentage charged by the third-party manager at each month-end against the fund's exposure to the relevant fund. In addition, the third-party manager of the Magellan Global Fund is entitled to charge a performance fee. As the annual performance fee charged is only identifiable in Magellan Asset Management Limited's Annual Financial Report, the performance fee for the March 2015 year has been estimated at each month-end over the 12 month period by applying the performance fee methodology, as described by the third-party manager.
- <sup>4</sup> Membership fees are the fixed dollar charge for membership in the KiwiSaver Scheme.
- <sup>5</sup> The investment in this fund was made under the target mix to international equities.
- <sup>6</sup> Kevin Stirrat, Craig Alexander, Malcolm Davie and Rob Mercer are employees of Forsyth Barr Limited (and not the manager). The manager has delegated part of the day to day management of the scheme to Forsyth Barr Limited.
- <sup>7</sup> Forsyth Barr Investment Management Limited (previously known as Forsyth Barr KiwiSaver Limited) is the manager of the Scheme and amalgamated with Forsyth Barr Funds Management Limited (the manager of the Forsyth Barr Investment Funds, into which the Scheme invests) with effect from 27 February 2015.

#### **Revised Disclosure Statement**

This disclosure statement has been revised as follows:

To clarify that the investment in the funds detailed in the top ten investments were made under the target mix to international equities as detailed in note 5.

To amend two references to Forsyth Barr KiwiSaver Limited in the Manager's certificate. Forsyth Barr KiwiSaver Limited amalgamated with Forsyth Barr Funds Management Limited (the manager of the Forsyth Barr Investment Funds, into which the Scheme invests) on 27 February 2015 to become Forsyth Barr Investment Management Limited. As a result, the references should have been to Forsyth Barr Investment Management Limited.
