## Forsyth Barr Commentary

AIR ranks highest in the G category, scoring well on many of the sub-categories, with only its long auditor tenure, the 51% shareholding by the NZ Government and a large number of anti-takeover devices negatively affecting the score. For C, in 2020 AIR committed to achieving zero net carbon emissions by 2050 and recently updated its decarbonisation strategy to meet this goal. This included Flight NZO, launched in 2022, which is a public campaign promoting its commitment to full decarbonisation (including scope 3 emissions). We acknowledge and support AIR's world-leading, strong and ambitious commitments in the sustainability space.
