Forsyth Barr Commentary

CHI's CESG score is a touch misleading as the historical data reflects its prior refinery operations before the significant transformation it made to become an import terminal. CHI expects its annual emissions (Scope 1 and 2) to decline 98% following the transformation. We estimate this change will increase its C score from a C+ to a B+ when CHI completes its first full financial year as an import terminal. Its G score is solid, and will improve if the oil companies that own significant stakes (and therefore classed as blocking shareholders) choose to sell down their shareholdings. CHI's E and S scores could be improved through better disclosure of CESG metrics as well as the development of water, waste, supply chain and human rights policies.
