## Forsyth Barr Commentary

CVT is strong in the C category which reflects its ambitious commitment towards becoming (1) carbon neutral by 2025, and (2) carbon positive by 2030. We have accepted these commitments as a proxy for net zero commitments. CVT is still in the early stages of collecting waste-related data, but has committed to future reductions (including packaging improvements) and has also reduced water usage by ~40% since FY17. The S score mostly reflects slightly lower scores in the diversity and human rights categories, but also no specific disclosure. The rating appears appropriate as CVT's ESG reporting appears to be one of the most effective in the sector and we expect improvements are likely to continue as CVT actions its sustainability strategy.
