Forsyth Barr Commentary

NZK is strongest on the S category. On the C side, NZK has a recent commitment to achieving Net Zero emissions by 2050 at the latest and became a signatory to the Race to Zero in 2021. NZK has been collecting waste from its Nelson sites for two years and is in its first year of collecting water consumption data. On the G side, it is the investor protections category which affects performance the most, particularly in light of the 2022 capital raise. The score feels right for being in the early stage of ESG data collection with plenty of room for evolution. We note the risks of warming seas and increasing fish mortality for the Company.
