Forsyth Barr Commentary

SAN has a long record of disclosures which supports its overall rating, which is stronger in the C category. The E category is impacted by environmental fines, which were issued in 2021 relating to a breach in 2017 by one of SAN's contractors. Considering its fishing operations (which use third-party contractors), and aquaculture operations, SAN's S and E categories are also impacted by no specific human rights policy, and waste/water scores. Overall, the score reflects SAN's record of reporting, which is currently ahead of its peers.
