

Forsyth Barr Commentary

Keeping the Ship Steady: Argosy (ARG) remains firmly in the Fast Follower category. Pleasingly, ARG's Carbon score improved markedly year-on-year (from B+ to A), testament to the work put in to prepare for its inaugural climate disclosures report which it published in May. Additionally, the company now has greater than five years of greenhouse gas emissions data in its inventory, which supported its score. Overall, however, ARG's score slipped a touch and now sits just below the averages for both its sector and the market. This is reflective of significant progress made by the market, as well as ARG's Social and Governance scores not quite keeping up with the rising bar in these sections. We note that ARG's 8 Willis asset has been certified as Wellington's first Green Star 6 rated commercial building; this supported its Environmental score which improved from a B- to a B.
