

## Forsyth Barr Commentary

Carbon Wheys: Synlait Milk (SML) was one of the two companies that declined to participate in our 2024 request for C&ESG data (same as 2023). While we have sourced as much of the data as we can, we note that the score will likely be depressed because of this. SML's score declined versus last year, with the only notable change being the decline in Governance which is a result of a negative score for its equity raise. While we acknowledge the raise was necessary to stop the company going into liquidation, it was heavily dilutive for minority shareholders who were unable to participate. SML's Carbon score is held back given it still owns fossil fuel reserves (coal boilers). We note the company has made a commitment to phase these out over the longer term. It is important to note that at the time of publishing, SML is yet to release its climate related disclosures, which weighs on its Carbon score.
